### Integrated Delivery System (IDS) Eligibility Criteria

The below chart, from the MAP Award application, illustrates the IDS information input table. In order to be eligible, the system of care must include multiple hospitals, a physician group, at least one additional service (SNF, Home Health, etc.) and an integrated revenue cycle management approach.
