

CANCELLED CHECKS CAN DECEIVE!

Would you accept \$70 as payment in full of a \$520 account? That's what one company had second Northwest Regional Hospital Accounting to do recently and next time it could be you. Here's the story:

> A customer owed \$520 on an account that had her husband agreed to pay \$10 a week. For five consecutive weeks he brought in his pay The store in turn, cashed the checks, each ceipt for that amount and \$90 in cash. The sixth week, the man made a \$20 payment with a bank cashier's check marked "final payment in full."

> ly contacted the man about the "error". He argued however, that, inasmuch as he had a copy of the bank cashier's check in the amount of \$20 and five cancelled checks, each company's endorsement, he could prove the account was paid in full. The creditor took the case to court where a decision was rendered in favor of the debtor.

It is suggested that this situation could have been avoided had the creditor rubberstamped the following information on the back of each check as it was cashed for the debtor:
