
# PHYSICIAN LED HOSPITALS

# CHALLENGES

#### PATIENT PROTECTION AND

#### AFFORDABLE CARE ACT

#### AKA ACA/PPACA

LIMITATION ON EXPANSION OF FACILITY CAPACITY.—Except as provided in paragraph (3), the number of operating rooms, procedure rooms, and beds for which the hospital is licensed at any time on or after the date of the enactment of this subsection is no greater than the number of operating rooms, procedure rooms, and beds for which the hospital is licensed as of such date.

#### PAYORS

Negotiating contract rates is discriminated.

#### STANDARDS AND REGS

Held to same standards as an acute care hospital.

#### ONGOING LEGISLATION

Mentioned in almost every session since 2010.


