# Maine Hospital Financial Status


- Hospital financial condition has stabilized but is weak
- The primary concerns are lack of workforce, inflation and unreimbursed expenses




# **Operating Margins**



#### **Summary**

Compared to 2015, fewer respondents believed that Maine hospitals provide all the care they need, provide good jobs, are involved in the community, and provide the right amount of free care to those who need it. As in 2015, respondents were the least likely to agree that hospitals are effective at controlling costs.

Note that the COVID-19 pandemic likely impacted how the public perceives hospitals, so results between 2015 and 2023 may not be directly comparable.

#### **Summary**

Compared to 2015, more adults believe that high salaries for hospital administrators is a major reason for rising hospital costs in Maine.

### **Act 167 Hospital Transformation**

#### Fall

Provider and community engagement meetings to determine community needs and where services should be offered in the state

#### Winter

Mathematica and Oliver Wyman will look at data and develop recommendations

#### Spring

Recommendations will be presented to hospitals, communities, and the legislature

#### Challenges

- Timing: late in the legislative session with no time to dedicate resources for change
  - Ticonderoga, NY: \$17M to convert hospital to primary care campus
- Workforce: demoralized providers will leave



### **AHEAD Model & Hospital Global Budgets**

#### CMS presented its AHEAD model comprised of:

- Total cost of care for the state
- Hospital global budgets
  - Vermont can develop its own global budget methodology
- Enhanced primary care and integration of mental health into primary care

#### Outstanding questions:

- Where does intensive mental health care and post-acute and long term care fit in?
- How does the governance/regulatory structure work?
- What do the numbers look like?

### 2023 Legislative Session

- When we met earlier this year, this line from my update seems awfully prophetic in hindsight:
  - "Many familiar battle lines, but opportunities for bipartisanship remain"



 Razor thin GOP majority in the House (198-R, 196-D, 3-I, 3 vacancies) required a more bipartisan legislative approach




- State Budget for SFY 24-25(HB 1/HB 2)
  - Medicaid Expansion NH Granite Ac
    Program 7 years
  - Provider rate increases (for LTC Server Behavioral Health)
  - HC Workplace Violence Prevention C
    Dept. of Labor




Hospital Association

- Workplace safety (SB 58), allowing for a warrantless arrest when a patient harms or threatens a health care worker in a health care facility
- Improve provider credentialing procedures (SB 72) New Hampshire

- OPLC Licensing –streamlining board processes
  - HB 409, relative to the organization of the office of professional licensure
  - HB 655, relative to the office of professional licensure and certification
  - HB 426, relative to the regulation of pharmacists-in-charge and pharmacies
- Workforce
  - SB 149, relative to nurse agencies



- 2024 Legislative Session getting underway
  - Retained bills: SB 82, relative to prompt payments
- LSRs (Legislative Service Requests) flooding in
  NHHA has flagged over 200 potential bills to follow
- NHHA Focus for 2024
  - Prior Authorization reform
  - Reauthorization of MET/DSH agreement



### Campaign 2024 Picking up Pace

 GOP field has grown...and is now shrinking




- Democratic field...much the same
