The examination process requires successful completion of two examinations – the end of module I examination and the module II case studies.

2. Facilitator Guide

The facilitator's guide provides suggestions and tips for conducting the practicum. Fundamental to the success of the practicum is the facilitator's ability to articulate important issues, structure and manage participant reflection, elicit dialogue among all participants and manage the means for summarizing learning. This checklist is designed to provide practical guidance in facilitating the chapter coaching course. This information presents recommended "how-to's" for a successful coaching session.

The coaching course materials are aligned with the realities of the health care business. The CHFP certification is designed to provide the learning needed to understand the business context today. Professionals today need to understand the context that produces the numbers rather than just the numbers alone. This perspective is what a chapter coaching course must provide - an understanding of the business context. The Certified Healthcare Financial Professional (CHFP) certification program is structured as two modules:

- Module I: HFMA Business of Health Care®
- Module II: Operational Excellence

3. Facilitator Presentations

Short PowerPoint presentations have been developed to assist the facilitator in setting the stage for coaching course sessions. The coaching course is a flexible and easily customizable structure. The presentations can be adjusted as needed depending on the delivery method; virtual vs. in-person. The PowerPoints are intended to introduce and/or summarize key topics, as identified by HFMA, but can be altered as determined by the presenter (highlight one or more specific topics, a specific section(s) of the online materials, area of expertise, etc.).

- HFMA Business of Health Care® Key Concept Guide: This guide is intended to assist your progression
 through the module by specifying important ideas, trends and practices that comprise the healthcare
 business environment. Candidates taking the time to use and/or customize this guide can develop a
 handy review tool. This guide consists of two sections for each course: learning exercises which are
 intended to provide practice in applying important ideas and concepts learned and key terms and
 concepts in a glossary format
- HFMA Operational Excellence Concept Guide: This learner's guide is intended to assist certification candidates in earning the Certified Healthcare Financial Professional (CHFP) designation by identifying the primary business challenges faced by providers, physicians and payers today. It is recommended that candidates preview the key-concept guide prior to working through the assessment. The time allowed for completion of this assessment is three (3) hours. This preview indicates the key business challenges that will be presented and attunes candidates to areas of professional practice that may be less familiar. The learner guide can then be used to focus additional outside reading and study on unfamiliar issues.
