Essential access for rural communities; must have 25 or fewer acute care inpatient beds and provide 24/7 emergency services.

3 General Acute Care Hospitals

Short-term, inpatient medical and surgical services and 24/7 emergency care.

5 Sole Community Hospitals (SCH)

Primary source of inpatient hospital services within a given geographic area for Medicare beneficiaries.

5 Specialty Hospitals

2 military hospitals 1 long-term acute care hospital 1 psychiatric hospital 1 adolescent psychiatric hospital

Tribal Health System

Alaska has a robust statewide tribal health system: 8 Tribal Hospitals 27 Health Centers 166 Village Clinics

Alaska's Top Industry

Healthcare is a leading economic sector in Alaska, paying out over \$3 billion in direct wages – more than any other sector.

- ✓ Healthcare accounts for 13% of all workforce earnings (> military, natural resource sectors)
- ✓ Healthcare employs 11% of Alaska's entire workforce – 43,000 jobs
- ✓ Projected to add 4,500 new jobs over next
 10 years more than any sector
- ✓ Total economic impact with multiplier effect: 75,400 jobs, \$4.75 billion in total income




The Workforce Problem

Healthcare Worker Shortage

There are too few Alaska healthcare workers to fill current service demands and vacancies are increasing. Alaska is projected to have the most significant shortages of any state moving forward.

- Approx 8,000 new healthcare workers needed in Alaska every year (churn + growth)
- Includes a need for nearly 1,400 new RNs
- Alaska training programs graduated less than 900 healthcare workers, including 324 RNs
- 21% nurse vacancy rate in Alaska hospitals; 118-day avg to fill a position
- Travel nurses earned an estimated 57% more on average than non-traveling RNs in Alaska




Delayed Discharge

In March 2024, acute care hospitals across the state reported close to 150 patients awaiting discharge for 7 or more days to post-acute care settings. This equates to 10% of the total bed capacity in Alaska.

Top three barriers to discharge reported:

- Skilled Nursing bed not available
- Lack of guardianship or healthcare proxy
- Insurer coverage issues
